I hereby undertake that-

- (1)The provisions of the Maharashtra Public Universities Act 2016,State Government/Relevant Central Authorities and Regulations made there under and the standing orders and directions of the university and State Government/Relevant Central Authorities shall be complied with;
- (2)The college has constituted a separate College Development Committee as stipulated in section (97) of the Act ;

- (7)The services of all teachers and non-teaching employees and the facilities of the college to be affiliated shall be made available for conducting examinations and evaluation and for promoting other activities of the university;
- (8)The directions and orders issued by the Chancellor, Vice-Chancellor and other officers of the university in exercise of the powers conferred on them under the provisions of this Act, Statutes, Ordinances and Regulations shall be mandatorily complied with;
- (9)There shall be no change or transfer of the management or shifting of location of college or institution, without prior permission of the university;
- (10)The college or institution shall not be closed without prior permission of the university;
- (11) In the event of disaffiliation or de-recognition or closure of the college or institution under section 121, the management shall abide by and execute the decision of Academic Council regarding the damages or compensation to be recovered from management.

We also understand that in case of non compliance of the conditions provided in above report is true and complete to the best of our knowledge and belief. The deficiencies will be complied as per university guidelines, failing action will be taken by the university as per Maharashtra Public University Act 2016.
